Markets Await US India Trade Deal

- Domestic dependent sectors to do well on RBI Rate Cut, GST Reduction and Good Monsoon
- For exports related sectors to do well US India Trade Deal has to happen
- Reports indicate India to reduce Russia Oil imports
- If Trade deal happens Markets will respond positively

India To Import Less Russian Oil

- US sanctions two major Russian Oil companies Rosneft, LukOil with effect from Nov 21st
- Post US Sanctions, sources says India and China will reduce Russian oil imports
- India currently imports 30 to 40% of total crude oil from Russia
- From Mid November onwards Indian oil direct imports to fall sharply from Russia
- Also Russian crude oil discount reduced from \$8 in 2022 to \$2 now

- Auto and Auto Ancillaries posted good results
- IT companies posted in line results
- Decent performance from PSU Banks, NBFC
- Strong performance in select companies in mid and small cap space
- Relatively better earnings season when compared to previous quarters


Legality of Reciprocal Tax CAPSTOCKS

- Already lower court gave verdict against Trump reciprocal tariff


US Reacts To China Pressure

US Fed Cuts Rate Further




US Fed Stops Quantitative Tightening


