Reliance Industries Limited has business in energy and materials value chain and in retail and digital services. The Company operates in four segments: refining, petrochemicals, oil & gas and organized retail. The refining segment includes production and marketing operations of the petroleum products. The petrochemicals segment includes production and marketing operations of petrochemical products. The oil and gas segment includes exploration, development and production of crude oil and natural gas. The organized retail segment includes organized retail business. It also has operations in the textile, SEZ development, telecom/broadband business and media sectors.

Torrent Power Limited is an integrated utility engaged in the business of power generation, transmission and distribution with operations in the states of Gujarat, Maharashtra and Uttar Pradesh. Its power generation projects include a 49.6 megawatts (MW) wind plant at Jamnagar, a 1,147.5 MW SUGEN gas-based mega combined cycle power plant near Surat, 382.5 MW gas-based UNOSUGEN power plant, 1,200 MW combined cycle gas-based DGEN power project, 422 MW coal-based AMGEN power plant at Ahmedabad, and 51 MW solar power project at Charanka, Patan. It transmits and distributes over 12 billion units of

power to around 2.2 million customers in the cities of Ahmedabad, Gandhinagar, Surat and Bhiwandi spanning an area of 408 square kilometers and franchise area of 721 square kilometers.

Its LCV include Traveller, Traveller School Bus, Traveller Ambulance and Traveller 26. Its small commercial vehicles include Trump 40, Trump 40 Hi-Deck and Trump 40 compressed natural gas (CNG) Hi-Deck.
