The company operates in three segments: IT and Business Services; Engineering and R&D Services; and HCL Software. It offers digital business services comprising application and maintenance, digital consulting, digital application and platforms, application modernization and integration, data and analytics, software as a service, and enterprise applications; and digital foundation solutions, including digital foundation consulting, hybrid cloud, digital workplace, cybersecurity, networks, intelligent operations, and unified service management. It serves financial services, manufacturing, life Sciences and healthcare, public services, retail and CPG, technology and services, telecom, media, publishing, and entertainment.

Larsen & Toubro Limited engages in engineering, construction, and manufacturing operations worldwide. The Infrastructure segment engineers and constructs building and factories, transportation infrastructure, heavy civil infrastructure, power transmission and distribution, water and effluent treatment, and metallurgical and material handling systems.
